## Regulation

The Messina International Clarinet Competition is organized by *Ente Autonomo Regionale Teatro di Messina*.

### **1.Registration requirements**

The competition is open to clarinetists of both sexes and all nationalities born after January 1st, 1986.

This musical contest aims at popularizing the knowledge of wind instruments, at fostering musical culture through the encouragement and the enhancement of young instrumentalists and, at the same time, at promoting the artistic and cultural heritage of the places that host the competition.

The applications must be:

a. compiled on the online form in the website: [www.teatrovittorioemanuele](http://www.teatrovittorioemanuele) within July 15th 2021.

All the applications received after the deadline or sent by other means of registration (registered mail, Pec, etc.) will not be accepted;

b. filled in all the data requested on the form accompanied by:

- copy of a valid identity document confirming the required prerequisite (birth after January 1st 1986);

- a brief biography: max 1400 characters in Italian/English (course of study and professional activities);

- a recent photo (max 2MB);

- a copy of the bank/postal transfer relative to the registration fee for the Messina International Clarinet Competition of Euro 120,00 (one hundred and twenty/00) paid to the following IBAN IT710010051650000000201736 in the name of Ente Autonomo Regionale Teatro di Messina. Other methods of payment of the registration fee will not be accepted. The registration fee is not refundable in case of missed attendance at the competition;

### **4. Prizes**

The jury may decide not to award the prizes if the artistic level of the candidates is not sufficient; in any case, the jury's decisions are final.

## **6. Arrival, Accommodation and Transport**

On September 29th 2021 at 4:00 p.m., all the candidates may be provided with information about the scheduled time of the Competition Secretary's Office at Teatro Vittorio Emanuele Via Garibaldi snc Messina.

Competitors must attend the rehearsals in good time bringing the identity documents.

Late arrivals will be excluded from the competition and may be readmitted at the incontestable discretion of the commission, only if the delay is justified by serious and documented reasons, providing that the rehearsals have not previously ended.

The auditions will be public.

Travel, accommodation and meals will be paid exclusively by the candidates.

On the competition website and at the secretary's office there will be information on hotels, B&Bs and youth hostels affiliated with the Ente Autonomo Regionale Teatro di Messina, the costs of which will be chargeable exclusively to the candidate.

## **7. Pianists / Accompanists**

The organisation of the Messina International Clarinet Competition will provide the official accompanying pianists necessary for the Competition. Each candidate will be entitled to one rehearsal per round. Additional rehearsals may be negotiated by the candidate directly with the pianists, taking their availability into account. The costs of the additional rehearsals are under the responsibility of the candidate and will be managed directly by the accompanist. Candidates may bring their own accompanist.

## **8. Expressed termination clause**

The organization reserves the right to postpone or cancel the Competition in the event of a worsening of the Covid 19 epidemiological emergency.

## **9. Disputes**

In the event of a dispute, the regulations in the Italian language will prevail.

For any dispute that may arise between the parties, the competent court will be the one in Messina.

## **10. Participation in the contest**

The participation in the competition involves the total and unconditional acceptance of these rules, as well as of any changes made by the artistic and organization all management. All rights concerning any audiovisual, photographic and radio recordings are reserved to the organization of the Competition and no payment can be requested for the abovementioned recordings and broadcasts. During the auditions and the prize-giving concert, all unofficial audiovisual and photographic recordings are forbidden.

Participation in the Competition implies full acceptance of the regulations.

## **11. Privacy**

The candidate's personal data are provided only to the secretariat of the Teatro Vittorio Emanuele of Messina and are used only for its organizations. Personal data are protected from irregular processing and are never transmitted to subjects with whom the theatre has no agreement of data processing. The candidate can always request personal data from the Theatre, view them and, if necessary, correct them. The biography and uploaded photo of the selected candidates will be published in the brochure containing the program of the Messina International Clarinet Competition.
